A non-refundable deposit of **40%** is due when this agreement is signed. **40%** of the balance is to be paid before the day of the shoot with the final **20%** of the balance to be paid against invoice on delivery of the final photographs.

Prices cover the **Qlik Studios'** travel to and from the venue of the photoshoot

Assignments outside the area are subject to surcharge depending on the distance

EVENT PACKAGE AND SERVICES INCLUDED FOR THE FEE STATED ABOVE:

- Retouched photographs
- Color graded photographs
- Photo prints
- Possible outfits change
- Picture frame (for platinum package or upon special request)

ENTIRE AGREEMENT:

This contract has been freely negotiated and shall be recognized as the entirety of the agreement between **Qlik Studios** and the Client. This Agreement supersedes all prior and simultaneous agreements between the parties. Changes or additions to this agreement are possible providing specifically placed in writing, signed by all the relevant parties.

RESERVATION AND PAYMENT TERMS:

Upon your signature and receipt of the aforementioned non-refundable reservation deposit, **Qlik Studios** will reserve the time and date agreed upon for you and will not make other reservations for that time and date.

The deposit is applied towards the contracted (Silver/Gold/Platinum) package. The Client understands and agrees that the remaining amount owed for the (Silver/Gold/Platinum) package described in aforementioned deposit amount is due before the day of the photoshoot and the final payment on delivery of the photographs.

Payment to be made by check or by electronic means. Account details will be supplied by Qlik Studios.

PRE-EVENT CONSULTATION:

The parties agree to a pre-event consultation before the photoshoot in order to finalize the actual shooting times & locations.

CANCELLATION:

In the event that the Client cancels the contracted services for the photography package outlined in this contract before the photoshoot takes place, the deposit will be forfeited.

In the unlikely event that **Qlik Studios** is unable to attend for any reason beyond their control: accident, illness or similar **Qlik Studios** will not be liable to compensate the Client except to return any monies paid.

DUTY OF CLIENTS:

Client will obtain all permissions necessary for Qlik Studios to photograph at the shoot. Qlik Studios has no duty to obtain permission of reception centers, churches, buildings, properties, or other locations to operate thereon. Client understands and agrees that any failure to obtain these permissions resulting in fines to photographer, or which prevent photographer from photographing the event is not the fault, liability, or responsibility of photographer.

Qlik Studios will not tolerate verbal or physical abusive behavior, nor will it share its time or compete with guest photographers for the attention of the subjects.

SAMPLE PHOTOGRAPHS DELIVERY:

After the photoshoot, Qlik Studios will provide the Client with a watermarked high-resolution sample folder of images corresponding to the number of photographs and prints agreed on in this contract

COPYRIGHT & DIGITAL IMAGES:

The photographs, images and prints produced by **Qlik Studios** are protected by Copyright Law (all rights reserved) and may not be reproduced in any manner without explicit written permission.

If the Client desires a copy of images in high resolution, so they can print their own copies in the future, these images may be purchased at a specified additional cost.

It is agreed that the **Qlik Studios** may use such photographs taken for any lawful purposes including for example, publicity, illustration, advertising, and Web content.
