**40%** of the balance is to be paid before the day of the event with the final **20%** of the balance to be paid against invoice on delivery of the final photographs.

Prices cover the **Qlik Studios'** travel to and from the venue of the event.

Assignments outside the area are subject to surcharge depending on the distance

## **EVENT PACKAGE AND SERVICES INCLUDED FOR THE FEE STATED ABOVE:**

- During event pictures
- Formal pictures at the reception
- Photo prints
- Red Carpet photos
- Other specified photographs by clients

## **ENTIRE AGREEMENT:**

This contract has been freely negotiated and shall be recognized as the entirety of the agreement between **Qlik Studios** and the Client. This Agreement supersedes all prior and simultaneous agreements between the parties. Changes or additions to this agreement are possible providing specifically placed in writing, signed by all the relevant parties.

## **RESERVATION AND PAYMENT TERMS:**

Upon your signature and receipt of the aforementioned non-refundable reservation deposit, **Qlik Studios** will reserve the time and date agreed upon for you and will not make other reservations for that time and date.

The deposit is applied towards the contracted event photography package. The Client understands and agrees that the remaining amount owed for the event photography package described in aforementioned deposit amount is due before the day of the event and the final payment on delivery of the photographs.

Payment to be made by check or by electronic means. Account details will be supplied by Qlik Studios.

## **PRE-EVENT CONSULTATION:**

The parties agree to a pre-event consultation before the Event in order to finalize the actual shooting times, locations, and Client's request list (in writing) for specific photographs. The Client will be responsible for, or have someone designated, to identify people of whom specific photographs are desired. The Photographer will not be held accountable for not photographing desired people if there is no one to assist in identifying people or gathering people for group photographs.

## **CANCELLATION:**

In the event that the Client cancels the contracted services for event photography outlined in this contract before the event takes place, the deposit will be forfeited.

In the unlikely event that **Qlik Studios** is unable to attend for any reason beyond their control: accident, illness or similar **Qlik Studios** will not be liable to compensate the Client except to return any monies paid.

## **HOUSE RULES:**

The Photographer is limited by the guidelines of the event official or the reception site management.

The Client agrees to accept the technical results of their imposition on **Qlik Studios**. Should negotiation with the officials for moderation of guidelines be necessary this is the ultimate responsibility of the Client not **Qlik Studios**.

Qlik Studios will not tolerate verbal or physical abusive behavior, nor will it share its time or compete with guest photographers for the attention of the subjects.

**SAMPLE PHOTOGRAPHS DELIVERY:**

After the event, Qlik Studios will provide the Client with a watermarked high-resolution sample folder. This folder will contain all photographs (in color) taken at the event.

**Qlik Studios** will also supply an additional sample folder of low-resolution images for sharing with family and friends. All photographs will have a watermark embedded, prohibiting unauthorized use.

The Client should as soon as possible provide **Qlik Studios** with a list of desired images to be printed, enlarged and/or digitally manipulated corresponding to the number of prints agreed upon in this contract.

The list must specify which images are to be in color or black and white. Printing of photographs cannot commence prior to receipt of this list.

**COPYRIGHT & DIGITAL IMAGES:**

The photographs, images and prints produced by **Qlik Studios** are protected by Copyright Law (all rights reserved) and may not be reproduced in any manner without explicit written permission.

If the Client desires a copy of images in high resolution, so they can print their own copies in the future, these images may be purchased at a specified additional cost.

It is agreed that the **Qlik Studios** may use such photographs taken for any lawful purposes including for example, publicity, illustration, advertising, and Web content.
